Subject: Minutes of Meeting held on 18-Nov-2024 under the chairmanship of Sr. DDG, NCCS with the Indian OEMs regarding security certification of IP Router and Wi-Fi CPE under MTCTE - reg.

An online meeting was held on 18-Nov-2024 under the chairmanship of Sr. DDG (NCCS) with the Indian OEMs who have ER certificates. The purpose of the meeting is to sensitise Indian OEMs on security certification of IP Router and Wi-Fi CPE which have been mandated. The list of participants is attached as Annexure-A.

- 2. At the outset, ADG(HQ), NCCS welcomed all the participants. A brief presentation was made by DDG(SC&HQ), NCCS to all the participants highlighting the important features such as online application filing process in MTCTE Portal, security certification process (Mandatory, Voluntary), detailed information about the timelines and clarification about the *Pro Tem* Certification, key clarifications/orders issued by NCCS/DoT HQ on security certification process, fee applicable, reimbursement of Test and charging fee for Startups and MSEs etc. It was also informed to the OEMs that IP Router and Wi-Fi CPE Products are already in Mandatory certification Category.
- 3. Sr. DDG (NCCS) stressed on the need to possess a valid security certificate and urged all OEMs to file the security certification applications for IP Router and Wi-Fi CPE as the last date for applying for ProTem certification is 30-Nov-2024. M/s DI3 INFOTECH LLP wanted some more time to file the application. Sr DDG(NCCS) pointed out that the security certification for IP Router and Wi-Fi CPE have been notified wef 01st July 2023 and have been postponed several times subsequently. He ruled out the possibility of further extension of timelines.

M/s MRO TEK Ltd mentioned that the testing fee, being charged by the TSTLs is high. Sr DDG(NCCS) requested them to explore the option of reimbursement of test and charging fee as notified vide DoT HQ OM No. 6-35/2024-CA/TEC dated 11th July 2024.

4. The following action points emerged during the meeting:

 OEMs were advised to refer to the NCCS website(https://nccs.gov.in) for various clarifications already issued on Product grouping, Guidelines, clarifications etc. regarding security certification process and for regular updates on security certification.

- It was clarified that there would be no extension envisaged for the last date (30-Nov-2024) in applying for *Pro tem* certificate for IP Router and Wi-Fi CPE.
- The office memorandum on "Reimbursement of Test and charging fee for Startups and MSEs" has been shared with participants.
- The OEMs/applicants were asked to complete their applications before the due date and were assured of continuous support from NCCS office in the application process. In case of any difficulty in filing the applications, OEMs were requested to send email to help.mtcte.tec@gov.in with a copy to ra4.nccs-dot@govcontractor.in and ra5.nccs-dot@govcontractor.in.
- 5. The meeting ended with thanks to the Chair.
