

3. Period of deputation:

(a) For Junior Engineer(Telecom)

(b) For Telecom Assistant (TA) and Lower Division Clerk (LDC)

As per DoT (Establishment Wing), OM No. 9-11(01)/2024-Estt dated 19-12-2024, the period of deputation shall be for an initial period of 1 year which may be further extended on administrative



grounds or till regular incumbent joins, whichever is earlier. The deputation can be terminated at any time prior to completion of deputation tenure as per requirement.

- 4. Regulation of pay and other terms of deputation: The pay and terms and conditions for deputation of the officials selected shall be regulated as per DoT OM no. 20-01/2023-SEA II, dated 31.10.2023 and its corrigendum dated 01.11.2023 (Annexure-E) and also DOPT OM No. DOPT-1726140763694 dated 28 March 2024, regarding consolidated guidelines on deputation/ Foreign Services for Central Govt. employees as the case may be, or any other instructions as amended from time to time.
- 5. **Age limit:** The maximum age-limit for appointment on deputation shall be not exceeding 56 years as on the closing date of receipt of applications.

6. Selection Procedure:

- a. The selection procedure will be as decided by the Head of NCCS. The decision of the department in the matter of selection through deputation shall be final and binding.
- b. Eligible and Willing candidates may apply as per application format Annexure 'B' forwarded through proper channel as per Annexure-D in prescribed format. Cadre controlling Authorities/Head of Department are requested to forward applications of eligible and willing candidates whose services can be spared on deputation immediately on their selection.
