Subject: Revision of TSTL Designation Application Fee Structure – Reg.

Ref: (1) Procedure for designating Telecom Security Testing Laboratories (TSTLs) Doc. No. NCCS/SLR/01 and its subsequent amendments

As part of Govt of India's initiatives to promote ease of doing business, the Competent Authority has accorded approval for downward revision Application Fee Structure for designation of Telecom Security Testing Laboratories (TSTLs).

Accordingly, the fee table specified in Para 9.3.j of the above referred document at Ref-(1) is hereby amended as follows:

I. First Time Designation as TSTL			
(i)	For 1 to 5 ITSARs in a single application	Rs 1,00,000 per application	Rs 50,000 per application
(ii)	For more than 5 ITSARs in a single application	Rs 1,00,000(for up to 5 ITSARs) + Rs 20,000 per ITSAR beyond 5 Total limited to a maximum of Rs 2,00,000 for a single application	Rs 50,000(for up to 5 ITSARs) + Rs 10,000 per ITSAR beyond 5 Total limited to a maximum of Rs 1,00,000 for a single application
II. Additional scope (adding new ITSARs in the scope of a designated TSTL, at a later stage, during validity of the TSTL designation period)			
(i)	Adding new ITSAR to existing TSTL	Rs 20,000 per ITSAR limited to a maximum of Rs 2,00,000 for a single application	Rs 10,000 per ITSAR limited to a maximum of Rs 1,00,000 for a single application

(ii)	For each SSR part of an ITSAR (for which TSTL is already designated for CSR)	NIL	NIL
III. Renewal of TSTL designation			
(i)	Renewal of TSTL designation	Rs 5,000 per ITSAR limited to a maximum of Rs 2,00,000 for a single application	Rs 2500 per ITSAR limited to a maximum of Rs 1,00,000 in a single application

Note: (i) Micro and Small Enterprises are required to be registered with Ministry of Micro, Small, Medium enterprise (MSME) and Start-up Enterprises are required to be registered with DPIIT, Ministry of Commerce and Industry, to avail of the discounted fees.

(ii) ITSAR means an ITSAR for a single device or CSR of an ITSAR group for Group Devices.

(iii) There is no limit on the number of ITSAR or CSR of an ITSAR group for Group Devices in a single application.

Application Fee Exemption: Government (Central/State Government) Testing Agencies/ Organisations /IITs and other Autonomous Bodies under the Government are exempted from paying TSTL designation fees.

The above amendment shall take effect from the date of notification.
