a) **Regarding method of submission:** For all Officers, RAs, Interns, Staff in NCCS and their family members, entries shall be submitted through Google forms (<https://forms.gle/GyNQDoDyjd7owLNr7>). The participant has to enter a 4 digit code. This will be the code to identify the responder who will be anonymous till the completion of evaluation. The responder shall also deposit a slip with this 4 Digit number along with his/her name in the physical Drop box kept in the office. The entry form was already published on 20-01-2026.

Further, ADET-2023 Batch officer trainees are on attachment to NCCS from 19.01.2026-23.01.26, and the entries are invited from these ITS officer Trainees also. The officer trainees may also participate and submit their entries through link (<https://forms.gle/wjTU24kqtjnSNjnJ9>). The link was shared to all Officer Trainees on 22-01-2026 for submission of the entries.

b) The last date for receipt of entries for NCCS Logo is extended till 30-01-2026, 5 PM.

विषय /Subject: Competition for Design/ Re-Design of NCCS Logo – reg.

With the approval of the competent authority, it is proposed to re-design existing logo/ create a new logo of NCCS which clearly reflects NCCS mandate/ objectives of NCCS as an organization (*Refer nccs.gov.in*).

2. Entries are invited for Design / Re-Design NCCS Logo. Guidelines for participants are as below.
 - a) All Officers, RAs, Interns, Staff in NCCS and their family members are eligible and encouraged to participate. Each participant can submit a maximum of 3 designs.
 - b) The Logo should be suitable for Govt organizations. The logo must not contain any provocative, objectionable or inappropriate content.
 - c) Logo must be original and should not violate any provisions of the Indian Copyright Act, 1957. The design of the logo must not infringe on the Intellectual Property Rights of any third party.
 - d) Participants are required to submit the logo design with text in Bilingual (Hindi and English). A brief explanation of the logo and how best it encapsulates essence of NCCS may also be given.
 - e) Logo should preferably be designed in colour.
 - f) Short Tagline matching with the NCCS mandate /objectives may also be given.
 - g) The participant shall provide the logo preferably as a file in JPG or PNG format in high resolution. Scanned image of Hand drawn designs will also be considered.
 - h) The logo can be designed on any application /digital platform / hand drawn.
 - i) Logo created should be easy to vectorize, as vector images do not get pixelated when enlarged.
 - j) All submissions will be the intellectual property of NCCS, and the participant shall not exercise any right over its use by NCCS.
3. The method of evaluation, method of submission of entries, details of prize/certificate shall be informed soon.
4. **Last date for submission is 22 Jan 2026.**
