### अधिसूचना

**विषय: सुरक्षा परीक्षण के अंतर्गत उपकरणों में सॉफ़्टवेयर परिवर्तन के संबंध में।**

अधोहस्ताक्षरी को यह सूचित करने का निर्देश दिया गया है कि आवेदकों को TSTL द्वारा सुरक्षा परीक्षण के दौरान अपने डिवाइस के सॉफ़्टवेयर में परिवर्तन करने की अनुमति दी जाती है, बशर्ते कि वे अनुलग्नक के अनुसार एक घोषणा प्रस्तुत करें।

2. परीक्षण के दौरान सॉफ़्टवेयर में संशोधन की स्थिति में, अनुलग्नक-I और अनुलग्नक-II के अनुसार दोनों घोषणा पत्रों को जमा करना आवश्यक होगा। तथापि, यदि DUT के सॉफ़्टवेयर में किसी भी प्रकार का परिवर्तन किए बिना केवल ITSAR BOM विवरण में टंकण त्रुटियों को ठीक करना हो, तो केवल अनुलग्नक-II को ही जमा करना पर्याप्त होगा।
